

Get Out the Vote 2016

Voter Registration:

- Check if you are registered to vote: www.sos.ca.gov/elections/registration-status
- Register online: registertovote.ca.gov
- Register in person at your county elections office by October 24: www.sos.ca.gov/elections/voting-resources/county-elections-offices
- Register by mail: Mail a Vote-By-Mail Ballot Application to your county elections office, to be received no later than October 31. After October 31, you will need to apply in person at your county elections office.

Election Day Voting:

- Vote in person: Find your polling place
 - On the back page of the sample ballot booklet found at your county elections office.
 - Call the California Secretary of State's voter hotline: (800) 345-VOTE (8683).
- Vote-by-mail:
 - Mailed in: Must be postmarked on or before Election Day and received by your county elections office no later than 3 days after Election Day.
 - Hand delivered: Ballots can be personally delivered no later than 8:00 p.m. on Election Day.

California Statewide Ballot Measures for November 2016 Election:

1. **Proposition 51:** Authorizes \$9 billion in general obligation bonds for Funding for K-12 School and Community College Facilities.
2. **Proposition 52:** Increases required vote to two-thirds for the Legislature to amend existing law that imposes fees on hospitals and directs those fees and federal matching funds to hospital-provided Medi-Cal health care services, to uncompensated care provided by hospitals to uninsured patients, and to children's health coverage.
3. **Proposition 53:** Requires statewide voter approval before any revenue bonds can be issued or sold by the state.
4. **Proposition 54:** Prohibits Legislature from passing any bill unless it has been in print and published on the Internet for at least 72 hours before the vote, except in cases of public emergency.
5. **Proposition 55:** Tax Extension to Fund Education and Healthcare.
6. **Proposition 56:** Cigarette Tax to Fund Healthcare, Tobacco Use Prevention, Research, and Law Enforcement.
7. **Proposition 57:** Allows parole consideration for persons convicted of nonviolent offenses, authorizes Department of Corrections and Rehabilitation to award sentence credits for rehabilitation, good behavior, or educational achievements, and requires juvenile court judges to make determination whether juveniles age 14 and older should be prosecuted and sentenced as adults.
8. **Proposition 58:** English Language Education.
9. **Proposition 59:** Campaign Finance.
10. **Proposition 60:** Requires performers in adult films to use condoms during filming of sexual intercourse.
11. **Proposition 61:** Prohibits state agencies from paying more for a prescription drug than the lowest price paid for the same drug by the United States Department of Veterans Affairs
12. **Proposition 62:** Repeals death penalty as maximum punishment for persons found guilty of murder and replaces it with life imprisonment without possibility of parole. Applies retroactively to persons already sentenced to death.
13. **Proposition 63:** Prohibits possession of large-capacity ammunition magazines, and requires their disposal by sale to dealer, destruction, or removal from state.
14. **Proposition 64:** Legalizes marijuana and hemp under state law.
15. **Proposition 65:** Requires stores to deposit carry-out bag sale proceeds into a special fund administered by the Wildlife Conservation Board to support specified categories of environmental projects.
16. **Proposition 66:** Changes procedures governing state court appeals and petitions challenging death penalty convictions and sentences.
17. **Proposition 67:** Referendum to Overturn Ban on Single-Use Plastic Bags.
